

INSTRUCTIONS FOR COMPLETING THE CONFIDENTIAL STATEMENT OF PROSPECTIVE AND EXISTING SHAREHOLDERS DIRECTORS AND EXECUTIVE OFFICERS

The statement is for official use only, and **ALL INFORMATION IS CONFIDENTIAL.** It is intended to assist the Central Bank of Barbados (Bank) in determining whether prospective shareholders, directors and executive officers are fit and proper persons to be associated with institutions licensed under the Financial Institutions Act, 1996-16 or the International Financial Services Act, 2002-5.

In completing this statement, applicants should provide at least one character or financial reference and one business reference, excluding references from current employers¹, relatives and business partners. All references must be:

- Dated within three months of the date of the application for a new licence or the date of this confidential statement, which ever applicable;
- Provided in original form and, in the case of institutions, must be provided on official company letterhead with the name and title of the signatory in capital letters; and
- Signed, and should include the signatory's title, name, address (including full mailing and email address), telephone and facsimile numbers.

Kindly note that Canadian residents/citizens are required to make an application for a police Certificate of Character to produce to their prospective employer. UK residents/citizens should apply for a Subject Access Enquiry under the provisions of Section 21 of the Data Protection Act, 1984. These documents must be attached to this form at the time of submission.

Character Reference - The referee should have known the applicant for a period of not less than 5 years and the nature of the relationship should be disclosed. The Referee should address the applicant's honesty, integrity and reputation.

Business Reference – This should address the competence and capability of the applicant in fulfilling the proposed role. The relationship must have been in existence for at least 3 years.

Financial Reference – This should be provided by a financial institution licensed to conduct business within Barbados or in another jurisdiction. The relationship must have been in existence for at least three years.

¹ Exceptions will be considered on a case by case basis, if the application relates to a regulated group.

Kindly note that if the shareholder is identified as a corporate entity; a confidential statement must be completed for the principals of that entity.

Please complete all questions in Attachment 1 indicating your response by either ticking the appropriate box or by writing in the space provided in **BLOCK LETTERS** and signing the confidential statement.

An electronic version of the form is available on the Bank's website, <u>www.centralbank.org.bb</u>.

As it relates to the administration of confidential statements:

- a. Statements should be refreshed every 4 years, indicating any changes from the previous statement. *If there are no changes, the individual only needs to complete the declaration form (Attachment 1A) at page 13.*
- b. If within 4 years from the date of submission of a confidential statement to the Bank, a shareholder, director or executive officer is party to an application for a new banking licence or assumes a position to which the statement would apply, then the individual is required to complete the declaration form (**Attachment 2**) at page 15.
- c. All identification information provided must consist of a notarized / certified photo bearing ID. Nonresident's identification information must be notarized, while Barbadian resident's identification information must be certified.

- d. Where identification information expires within 4 years, the individual is required to submit a certified copy of current identification information within 30 days of expiry.
